



## **Riviera Holiday Home Reservation Terms & Conditions**

- 1 In order to reserve our holiday home, we need the names, addresses and ages of all people in party, together with Date of requested Arrival and Date of requested Departure Plus any valid Discount Code to qualify for available discounts.
- 2 Return the reservation contract filled in and signed together with the deposit of £100 (Off Peak or £150 Peak). Within 5 working days of receiving confirmation. Please make Cheque payable to Mrs G. McGarvie.
- 3 Payment in full must be received by us at least 6 weeks before the due arrival date (This includes the additional £125 security deposit & £16 campsite supplement.)
- 4 A Maximum of 6 people to stay in the mobile home.
- 5 No pets are allowed in the mobile home.
- 6 Cancellation
  - Up to 6 weeks before the due arrival date we will fully reimburse the deposit less a £20 administration fee.
  - If less than 6 weeks before the due arrival date NO reimbursement can be given (Unless we can rent the mobile home to another person, in which case a full reimbursement will be given.)
- 7 In case of late arrival or early departure; No reduction can be given.
- 8 No reservation is confirmed until you receive our confirmation.
- 9 **The holiday home MUST be cleaned and straightened up before leaving, if not there will be a charge of £30 per hour (Charged by the site for cleaning, this will be deducted from the security deposit)**
- 10 A charge of at least £30 up to the full cost of replacement of any items will be charged from the security deposit for any damage incurred or loss of inventory
- 11 Deposits & Costs.
  - A security deposit of £125 is charged for every booking and must be paid at the time of paying the full amount of the holiday (Must be paid in full 6 weeks before due arrival date) This will be refunded at the end of your stay after the holiday home has been checked clean and correct.
  - A deposit of £100 (Off Peak) and (£150 Peak) to be paid within 5 working days of the confirmation e-mail from us.
  - A local tax is payable in addition to your rental costs the tax is charged at 0.6 euros per day person. This equates to approx £10.50 for a family of 4 per week
  - A charge of £35 per week is charged by the campsite for full use of the site facilities. **This is included in the price.**



**£25 per week discount available on all off peak weeks with a valid discount code.**

**Further £25 available for a 2<sup>nd</sup> or 3<sup>rd</sup> week (Off peak only)**

I understand that I must pay the deposit in full within 5 days of receiving confirmation of my booking.

I understand that the holiday home must be cleaned prior to leaving at the end of the holiday and left in the same condition as when starting the holiday.

I understand that I must pay a security deposit of £125 at the time of paying for the holiday in full, and that if any damage is caused, or if the holiday home is not left in a clean state on leaving the holiday home I will be charged as per the conditions above.

I understand that I must pay for the holiday in full no later than 6 weeks before the arrival due date.

I understand there is a local tax charge of 0.6 Euros per day (This equates to @ £10.50 per week for a family of 4)
